





- Curriculum bloat too much to teach and learn
- Professional identity tied to business model to a product not to contemporary understanding of <u>value</u>
- Unacceptable workplace conditions (particularly in corporate community pharmacy)
- Finance models that must be changed to make practice advancement possible
- Practice models that need to be changed




Graduating Students: What are your current plans for primary employment upon your graduation from the college/school of pharmacy?

Graduating Students Data: If I were starting my college career over again I would choose to study pharmacy.


